In accordance with RSA 126-A:84.IV., I am pleased to submit this annual report regarding the Town of Belmont Opioid Litigation Settlement distribution of \$4,978.15 received in 2023 and to date a total of \$38,910.50. In 2023 we used \$24,622.20 to purchase a TruNarc Laser for field testing drugs in the field. This laser allows the officers to safely test the substances in the field without risk to them getting exposed to the drugs. Funds were also allocated to train the officers on how to use the laser.

These funds were deposited into an Opioid Litigation Settlement Revenue Fund, as designated by the Board of Selectmen. The Town of Belmont continues to review the community needs and developing a fair and transparent process for how best to spend the funds.
