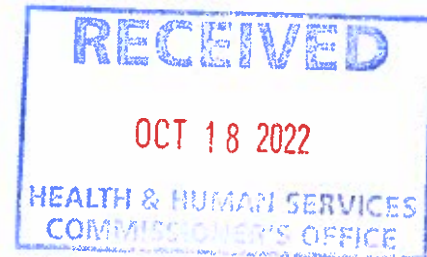

In accordance with RSA 126-A:84,IV., I am pleased to submit this report regarding Grafton County's distributions from the Opioid settlements. To-date Grafton County has received three (3) disbursements totaling \$131,600.71, including the latest disbursement that was received on October 11th.

The funds have been deposited in a special revenue fund to be used for expenses allowed under the Trust stipulations. To-date, Grafton County has spent \$901.37 on Medication Assisted Treatment (MAT) at the Grafton County Department of Corrections. We will continue to use the funds to pay for our monthly MAT expenses.

In addition, the Commissioners have set up a committee that is meeting and discussing potential expenditures that will help combat the Opioid use issues within our county.
