GM SUMMARY
The purpose of this memorandum is to communicate the status of the Appendix K flexibilities approved and operationalized under New Hampshire’s Choices for Independence (CFI), Developmental Disabilities (DD), Acquired Brain Disorder (ABD), and In Home Supports (IHS) Waivers.

Appendix K Unwind

The New Hampshire Division of Long Term Supports and Services’ (DLTSS) Bureau of Elderly and Adult Services (BEAS) and Bureau of Developmental Services (BDS) is providing the following information regarding the status of flexibilities approved in the CFI, DD, ABD and IHS 1915(c) Home and Community-Based Services (HCBS) waiver Appendix K amendments (“Appendix K flexibilities”).

Any Appendix K flexibilities that have not already ended, been included in State administrative rule or incorporated into an amendment to the applicable waiver, will sunset on November 11, 2023. DLTSS has created the attached “Appendix K Unwind Chart” to provide the status of all operationalized flexibilities.
